The service will be available to a customer, on acceptance of a Direct Debit mandate by the London Gateway Port Ltd's banking facility (CNS), through means of a username and password to be supplied by e-mail and written confirmation at registration.</p> <p>4. Cancellation of Direct Debit will lead to removal of access to the service.</p> <p>5. Notification to change Direct Debit details are required 15 days prior to the next due invoice date, and requires receipt of a completed new direct debit mandate. An invoice will be generated, for "Peak, No Show, Late Booking Cancellation, Permanent ID card and Replacement ID Card" fees. CNS will be invoicing all transaction types on behalf of LGPL.</p> <p>7. Payments will be collected by Direct Debit 30 days after the date of invoice and can be identified by the reference 'CNS Ltd. on behalf of LGPL'. Interest at 5% above Lloyds TSB Bank base rate will be charged on all sums (net of VAT or other applicable sales tax) not paid within 30 days. Payments made by other methods are payable to 'Community Network Services Limited'</p> <p>8.
